THURSDAY AUGUST 11th

COMMITTEE ON COMMITTEE MEETING: Grand Chef de Gare Larry Winger called the Committee on Committee meeting to order at 1:00 P. M. following a Pledge of Allegiance, Roll Call was taken by the Grand Correspondant showing Chairman Joe Story was excused. FINANCE COMMITTEE MEETING: Grand Chef de Gare Larry Winger called the Finance Committee to order at 1:26 P. M. Following the Pledge of Allegiance the meeting Roll Call was taken by the Grand Correspondant. The Grand Chef, Grand Correspondant, Grand Commissaire Intendant were present. Sous Commissaire Intendant Phil Nelson was not in attendance. Finance Committee members George Heck and Ken Kozubek were in attendance. Chuck Cooney was excused due to his health.

The meeting was turned over to Grand Commissaire Intendant Jim Vissers for his report. Review of the 2021-2022 finance report to date. The Grande ran close to \$300 over budget. Miscellaneous expenses of \$5,565.04 was mainly for the new dock at the flowage and the new Grande Voiture flag. Investment portfolio is valued at \$XXXXXXXXXX. Total net worth is \$XXXXXXXXXXX.

Jim also informed those present that in 2008 the Grand Correspondant and Grand Commissaire Intendant (Jim Chapin) voluntarily took a 15% pay cut due to the economy at the time. He has now reinstated the amount which come to a increase of \$475 for the Grand Correspondant and \$180 for the Commissaire Intendant.

The price for rooms and gifts for National guests was raised in the budget due to inflation. Discussion on purchasing or at least assisting with the new tractor and attachments for Camp American Legion! They are in desperate need of that form of new equipment. Many opinions and comments on the subject!

The meeting was closed at 1:57 P.M.

TIME AND PLACE COMMITTEE MEETING: Grand Chef Larry Winger called the Time & Place meeting to order at 2:15 P. M. following a Salute to the Colors and Pledge of Allegiance and Roll Call with everyone present. Mary Schaller was introduced from the La Crosse Cabane # 830 who gave a run down on the 2023 Midwinter Petite Promenade which will be held in West Salem. Registration and Hotel Reservation forms were handed out.

As of today there are no bids sent in for the 2023 Grande Promenade & Rendezvous. Ray Pasbrig spoke on the West Allis American Legion Post hosting the event. The closest hotel is 2 miles away.

Many locations were mentioned. However no one wanted to come forward and officially put in a bid to host the 2023 Grande Promenade.

Fall Cheminot will be in Black River Falls on October 22nd at the Orange Moose Best Western. All questions and concerns were answered. That evening the Grand Chef de Gare and Grande Presidente's Testimonial will take place.

BADGER FORTY ET EIGHTER: L'editeur Tom Orval spoke on the upcoming issue of the Badger Forty et Eighter. Need articles and pictures within 3 weeks. Labor Day weekend is the deadline. All questions were answered.

NATIONAL PROMENADE COMMITTEE MEETING: Corporation President Don Emley gave a complete update on what is going on with the hotel and arrangements along with Voiture National. There will be a Children's Party this year. Many volunteers have indicated that they wish to help with the Registration table and 50/50 Raffle. Tom Orval gave an update on the Early Bird party. It will again be a Tail Gate theme.

FRIDAY AUGUST 12th

Grand Chef de Gare Larry Winger called the 101st Annual Grande Promenade to order at 9:00 A.M. Colors already being posted the Voyageurs saluted the Colors and recited the Pledge of Allegiance. Invocation the Grand Aumonier Ray Kline and the placing of the POW-MIA Seat Cover by Grand Sous Chef de Train Dave Behling with the recital of the Preamble and the placing of the Alter Cloth, the Promenade was opened for such business as to come before it.

Approval of the Official Call as was in the summer edition of the Badger Forty et Eighter. A notion was offered, seconded and carried.

Approval of the 2020 Grande Promenade minutes, the 2021 Midwinter Petite minutes and the 2021 Midwinter Petite minutes were offered, seconded and carried.

Grand Chef de Gare Larry Winger gave greetings. General Chairman Melissa Guthmiller gave greetings. Chef de Gare Dave Lindberg of Monroe County # 804 also gave greetings.

Grand Correspondant Tom Orval introduced the Distinguished guests to include Chef de Chemin de Fer Passe Don Emley, Sous Chef de Chemin de Fer Gary Cox of Tennessee and National Sous Directeur of Box Car & Booooo Vikings fan Steve Dircks of Minnesota. Roll Call was taken by the Grand Correspondant.

RULES AND ORDER: Chairman John Edelblute gave the Committee's report with the Delegates being in line with the number of Voyageurs that each Locale has. Rules will be followed in the Grande Voiture Constitution and Bylaws. A copy of the Roberts Rules and Order in in the folder and they stated that the Rules & Order sheet is also in the folder. Would like to see a change when addressing the Membership that when you address the body, you will state which Locale you belong to! Notion was offered for acceptance of report. Seconded and Carried!

ACTIVITIES: Directeur Ken Kozubek informed that for a down year the Grand didn't do all that bad. Out of 33 Locales, 15 submitted reports. 33,522 Voyageurs participated in 1175 events for 27,096 hours, \$64,949.38 and 71.094 miles. There was one Locale that had rolling stock. Insurance is eating most Locales up. Notion was offered for acceptance. Seconded and carried!

AMERICANISM: Ken Laatsch stated that 17 reports were turned in and 2 were not filled out and another two were filled out but not marked down as to which Locale filled it out. Hours totaled 26,88 total miles came to 80,906 and cash spent totaled \$48,142.00. It all comes to \$\$219,035.00 total cash and services. As for per capita divided by 855 in membership it comes to \$256.78 per member in the Grande Voiture. Flags for 1st Graders was again very good with approximately four thousand flags distributed. Acceptance of the report. Seconded and carried!

NATIONAL BOX CAR ASSOCIATION: Directeur John Aasen began his report with a bit of history on the Box Car Program and what they do as to where the money goes to at the end of the year. This last year Wisconsin sold 225 pins and 225 each for Box Car Crew and Associate cards totaling \$1,240.00. John thanked his Sous Directeur Jack Vissers for assistance in the Program. A notion was offered for acceptance, Seconded and carried.

CARVILLE STAR: Directeur Jim Witte let the membership know that he only received 12 reports this last year. 100 pins were sold, Also 500 miles were traveled for the program and approximately 400 hours and \$54.00 in donations. Notion for acceptance of the report. Seconded and carried.

CHILD WELFARE: Grand Directeur Eric Diekmann gave his report which included assisting five families this last year or 18 children totaling \$3,906.00. Wisconsin once again led all of La Societe is assisting children who were victims of house fires or other natural disasters. Notion for acceptance of the report which was seconded and carried!

CHARLES ARDERY REPORT: Grand Correspondant Orval reported that a total of 18 children were assisted this last year in La Societe with 5 coming from Wisconsin. Total Funds in the Unrestricted account is \$977,232.92 and \$2,040,315.85 for a total of \$2,394,997.51 in the Ardery Fund. Notion to accept! Seconded and carried!

WISCONSIN DISASTER RELIEF FUND: Submitted by Jim Vissers, this fund was established in 2009 and intended to supplement the Ardery Fund once the Grand used up all funds for the year available through the Ardery Fund. \$100 per child and \$500 per family. Maximum of \$2,000 a year can be expended. Current balance is \$5,645.82 in the account which is an increase due to money collected from the Grande and Midwinter Petite Promenades and a donation from the Al Ross Memorial. Notion for acceptance or report. Seconded and carried!

NURSES TRAINING: Directeur Sukowski started his report and his cell phone went off! \$5.00 fine! One Nurse will graduate this late fall. There is a problem with the NT report the way it is laid out. There was only one scholarship that was awarded. Notion for acceptance. Seconded and carried.

JACK D. WILSON FUND: Grand Commissaire Intendant Jim Vissers reported that there was \$21,795.95 in July of 2021. Income was \$105.00 and \$1,500.00 was spent on the three \$500.00 scholarships. This leaves a balance of \$20,400.95. Submitted for approval. Seconded and carried!

GEORGE B. BOLAND FUND: Tom Orval reported that this last year there were 8 inquiries into the Boland Fund and 15 applications were received. Out of the 15 applications, all 15 were accepted with \$906.66 going to each scholarship winner. In the fund there is \$287,532.70 in the unrestricted area of the fund with \$1,179,600.44 in the Restricted section for a total of \$1,467,132.84 total monies in the account. Notion to accept report! Seconded and carried.

POW-MIA: Jim Bassett was excused due to his wife Sharol still rehabbing from her illness. Read by Jim Vissers. The POW-MIA Scholarship Program relies on the sales of merchandise such as pin sales along with the bolo ties. In 2023 the program wisely changed back to the traditional pin. Voyageur Orval has the new pin if you want them on consignment or wish to purchase one. 14 Locales submitted Communique reports. However only 7 showed activity. There were 1,498 man hours, 15,707 miles traveled with \$7,707.00 dollars spend for a total dollar equivalent of \$22,413 in support of the POW/MIA Scholarship Program. Notion for acceptance of the report. Seconded and carried.

PUBLIC RELATIONS: Directeur Tom Orval spoke on all Locales trying to promote and maintain a positive image of La Societe to the general public. Press releases and pictures should be sent to the local newspapers. 18 Locales submitted Communique reports. Richland County # 1268 was the 2022 winner with honorable mention going to Milwaukee # 1519. Notion for acceptance of the report. Seconded and carried!

RITUAL: Grande and National Directeur Steve Bradley reminded everyone to use the Blue Ritual and Manuel of Ceremonies. If your Locale is using some other form of Ceremonies, throw them out and get the correct Ritual and Manuel of Ceremonies manual. Steve then spoke on the awards that will be presented in Green Bay. There is also a Color Guard Award. If you would like and have time, figure out a new password for La Societe. There have been different requests for different aspects of the manual that they would like changed.

Voyageur Steve brought a number of automatic items that all Voyageurs should go by to include wearing the proper Chapeau, prayer, etc. Questions were asked and answered. Notion was offered to accept the Ritual report as given. Seconded and carried!

SPECIAL AWARDS: Ron Pfalzgraf stated he has not been able to do much being that his wife has been going through cancer treatments. We do have a Law Officer, Hero of the Year and a Voyageur of the Year Award. Our Hero of the Year was also chosen as the National hero of the Year. There are many Law Officers and Hero's who are very deserving in the papers. Notion for acceptance. Seconded and carried!

VAVS: Directeur Mitchell asked if Middleton VAVS Rep Gerry Scalissi would be in attendance. No because he just had some kidney stones removed. Voyageur Mitchell spoke on all of the things Gerry Scalissi does at the Middleton VA. Thirteen Locales reported. All figures such as miles traveled, hours volunteered, Services rendered, etc. Need more volunteers in Middleton. Notion for acceptance. Seconded and carried!

ZABLOCKI VA: Representative VA Rep John Edelblute IV stated that things are moving along rather normally at Zablocki. Business as usual. He was able to secure \$450 originally requested for items in the Emergency Department from the wish list. The money was rerouted to a fund to help with social outings for the Veterans. Representatives are needed in many of the VA facilities around the country. For those going to the National Promenade, please attend the VAVS seminar which John will be participating in. Notion and seconded for acceptance. Carried!

TOMAH VA: George Bloom started out informing the membership that VA Rep to Tomah Don Thrill had passed away recently. George had logged 295 hours, 8,341 in hours and 129 hours in Aide to Vets. Notion for acceptance; seconded and carried!
